### **Application Qualifications**

### Applicant should:



1. Be a senior high school graduate and should be at least 18 (Before March 1, 2021);



2. Be a non-Chinese citizen and hold a valid ordinary passport;



3. Be physically and mentally healthy, meet the physical examination requirements for Chinese Visa or Residence Permit applicants in China and the physical examination requirements of the major to study in BFSU to ensure normal study and life in China;



4. Have no violation of disciplines, no records of public security punishment or of criminal conduct; be friendly to China and behave well; comply with Chinese laws and university regulations, and respect Chinese customs and manners;



5. Have a valid transfer certificate if transferring from another domestic university;



 $6.\ Have\ passed\ the\ IELTS\ 5.0$  and TOEFL 60.

Applicants with zero basic Chinese language proficiency can also apply.
